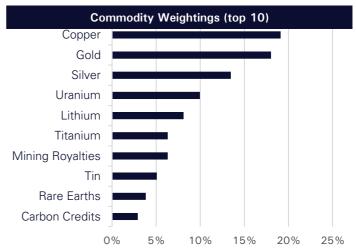
Investment strategy

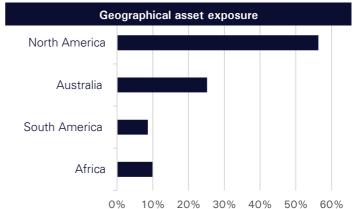
- The Fund invests in global mining and energy companies capitalising on the under researched nature of the sector.
